ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the California Corporations Code, hereby adopts the following Articles of Incorporation, in compliance with Section 5130.

ARTICLE I

The name of the corporation shall be: California Chapter of the ASSOCIATION OF INSPECTOR GENERAL

ARTICLE II

A. This corporation is a nonprofit Public Benefit Corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.

B. The specific purposes for which the corporation is organized are: (1) to provide a civic, educational, charitable, and benevolent organization for the exchange of ideas, information, education, knowledge, and training among governmental Inspectors General; and (2) to foster and promote public accountability and integrity in the general areas of the prevention, examination, investigation, audit, detection, elimination and prosecution of fraud, waste and abuse, through policy research and analysis; standardization of practices, policies, conduct and ethics; encouragement of professional development by providing and sponsoring lectures, debates and other educational programs; and the furtherance of professional qualification, certification and licensing.

ARTICLE III

ARTICLE IV


A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Internal Revenue Code section 501 (c) (3).

B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

ARTICLE V

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Internal Revenue Code section 501 (c) (3).
