## Illinois Attorney General Investigations, The When, How and What

Identify the type of matters that the AG office generally handles and, at a high level, the process involved from intake to enforcement.

## Biases in Decision Making: Avoiding the Circumstances that Create Poor Judgments

Identify the ways minds, personalities, life experiences, and social structures influence how one takes in, processes, and uses information in our decision-making and how one may be potentially influenced by bias.

Identify the impacts of social distancing and video conferencing on decision-making, particularly judgments of other people. Identify preventative measures to improve individual and organizational decision-making processes.

## How to Detect Antitrust Crimes and Work Antitrust Investigations with the Procurement Collusion Strike Force

Overview of the per se criminal antitrust offenses (and how prosecutors prove them), how criminal antitrust affects governmental operations, the red flags of collusion (and how and to whom to report), and some reflections from a prosecutor's perspective on procurement practices. The speakers will use real-world examples, and actual evidence to illustrate these topics. Additionally, the presenters will provide information about the current inter-agency initiative, the Procurement Collusion Strike Force and discuss the work they are doing as part of the COVID response.

## Case Study: Audit of the Chicago Low-Income Housing Trust Fund Housing Quality Inspections

In 2019, the Chicago Office of Inspector General completed a performance audit of the Chicago Low-Income Housing Trust Fund, which supports affordable housing for some of the city's most vulnerable residents. Through this case study, participants will learn about assessing agencies with little regular oversight, evaluating risks posed by manual recordkeeping, and building rapport despite difficult findings.
