

## John A. Curry – J.D., CIGI, CFE


John Curry currently serves as a Board Member of the Association of Inspectors General - NY/NJ Chapter and previously served as the 2<sup>nd</sup> V.P. of that Chapter.

John Curry is a retired Sergeant from the NYPD having worked from 1986 through 2006 and is a licensed and practicing attorney for the past twenty-five years and is admitted to the New York State Bar, the Eastern District of New York, the Southern District of New York and the United States Supreme Court. Mr. Curry began his law enforcement career in the 46<sup>th</sup> Precinct in the Bronx, and then transferred to the Intelligence Division while attending New York Law School in the evenings. He graduated and was admitted to the NYS Bar in 1997, and was awarded the Eliot H. Lumbard Scholarship from The Police Foundation and attended the University at Albany and earned a MA in criminal justice. Mr. Curry was assigned to the Legal Bureau of the NYPD and after having served in several capacities, including Managing Director for Legislative Affairs, was tasked lead counsel in a civil case filed against the "Bloods" gang as a criminal enterprise. Mr. Curry retired after twenty years of service as the Executive Officer of the Civil Enforcement Unit. John Curry then was appointed an Administrative Law Judge for the New York State Liquor Authority and issued over one hundred post hearing decisions and was later hired as Regional Counsel for the Recording Industry Association of America (RIAA) between 2007 – 2009 and elected to serve as President of the New York City Trademark Task Force.

Mr. Curry was hired by the New York City Business Integrity Commission (BIC) in 2009 to assist with combatting Organized Crime in the areas that BIC regulated. Mr. Curry began as a Senior Managing Attorney and was later promoted to Assistant Commissioner for Legal Affairs and Deputy General Counsel. While at the BIC Mr. Curry led a several year criminal investigation that resulted in guilty pleas and restitution orders being secured in the EDNY and was the focus of Mr. Curry's presentation at the AIG Annual Conference in Austin TX in 2017 titled: *How to Identify Union Fraud & Breakdown and Analysis of a Double-Breasting Investigation and Prosecution*. While at the BIC, Mr. Curry served under three different Commissioners and was designated the Director of the Background Investigations Unit and the Disciplinary Advocate. As Disciplinary Advocate he co-authored the *Business Integrity Commission Code of Conduct and Employee Handbook* and negotiated the settlement of all disciplinary cases and litigated the charges before the Office of Administrative Trials and Hearings, NYC Civil Service Commission and the Supreme Court – Civil Part when Article 78 proceedings were filed.

John Curry is currently employed as the Project Manager of Guidepost Solutions where he is assigned to the Monitoring, Compliance and Investigations Division. His assignments include several large private and public construction projects and involves working collaboratively with various local, state, and federal law enforcement and prosecutorial agencies.
